There will be two approval processes from finance committees.

- 2. MDE Admin meal program review Code of Conduct: A new policy will need to be created in order to complete the code of conduct for federally funded programs such as our meal program. along with disciplinary actions that will be taken.
- 3. MDE Admin meal program review Procurement Procedures: We looked over the procurement procedures for Federally Funded Programs. Mary will get approval from the state for the new policy prior to approval.
- 4. Alumni mailing: The fall mailing will not be going out due to all the extra mailings for the Capital Campaign. Plan is to send out a spring mailing.
- 5. Health Insurance: Open enrollment is underway. Premiums are going up roughly by \$800 for the school. Currently nine full-time employees utilize the offered health insurance. The school pays up to 70% for each employee. Employee's payment would be increasing by \$40 per month. Premiums have not increased for guite some time.
