AGREEMENT

I agree to pay the tuition due of \$2,850 per student/\$7410 for family of three or more according to the plan checked below.

- Pay in full by September 25, 2026
- Pay half by September 25, 2026 and the balance by January 22, 2027
- Pay in 9 month installments, due the 1st of the month, beginning Sept. 1, 2026, and completed May 1, 2027
- Pay in 12 month installments, due the 1st of the month, beginning July 1, 2026 and completed June 1, 2027
- We (I) would like an appointment to discuss our financial commitment to Holy Family School

All tuition must be paid within the fiscal school term (July 1 - June 30). If tuition is not current at the time of registration in spring or the family has not met with the Principal or Pastor to discuss their financial commitment, they will not be allowed to register. Registration at a later date will be contingent upon space. Families who withdraw during the school term are responsible for the prorated portion of the tuition.

I have enclosed the \$175 per student downpayment fee.

(This deposit will be applied to tuition, which will be reflected on the September, 2026 statement.)
